We are pleased to submit this proposal for Professional Services in connection with the project referenced above.

This Agreement is by and between Brown Sardina, Inc., a Massachusetts Corporation, and OMR Architects, Inc., (OMR, Client).

SCOPE OF SERVICES

<u>Phase 1 - Site Investigation, Soil Characterization and Reporting:</u> Review existing reports, plans and other available information regarding the soils and groundwater conditions in the area proposed for reconstruction.

Manually excavate shallow test pits to evaluate topsoil and the drainage characteristics of the subgrade and collection of soil samples. Document soil horizons and evaluate depth to groundwater and/or bedrock if encountered. We anticipate a minimum of fifteen test pits will be excavated, dependent upon field conditions observed.

Soil samples will be analyzed by Pine and Swallow or submitted to the University of Massachusetts Soil Testing Laboratory for gradation, pH, nutrient, percent organic and soluble salt analyses, as appropriate. Conduct in-situ infiltration testing of the subsoil encountered as required. Additional laboratory infiltration testing will be carried out on topsoil samples collected as necessary.

Based on the results of our field and laboratory investigations, provide general reconstruction recommendations in a letter report format, including:

- A. A description of sampling methodology and the findings and conclusions of the subsurface investigation.
- B. An evaluation of hydrogeologic conditions relative to ground water conditions including recommendations for improved surface and internal soil drainage.
- C. An evaluation of planting media for the field including recommendations for modifications to the existing soils, and to determine if adequate soil volume is available for future construction.
- D. Provide reconstruction recommendations, including material handling procedures, soil profiles, and recommendations for soil materials.

Phase 2 – Schematic Plans and Specifications

Provide profile sketches and soil for drainage and athletic field construction. Provide soils specifications for lawn, planting and sport field soils. Prepare sections and profiles sketches to incorporate into the final documents.

Phase 3 – Compliance Testing

Collect samples of soil materials and test samples for consistency and for comparison to the construction documents. Three site visits are anticipated in this phase.

FEES AND TERMS
