## 1.0 Model Specifications

- 1.1 Scale: 1/64"=1'-0" with an approximate base size of 40"x 36.
- 1.2 Topography: Foam topography showing <u>smooth</u> contours painted one color. A 136-0" change in elevation has been estimated for this model. A 6" curb will be shown where required.
- 1.3 Site Work: Show all roads and parking areas painted one color. Show sidewalks and pathways painted one color. Show special pavement painted various colors. Show retaining walls painted one color where required. Show sports playing fields painted one color with the appropriate markings.
- 1.4 Buildings: A separate price to show buildings has been estimated. These buildings will be constructed using Ren and various other plastics, showing basic massing and roof volumes. Windows and doors will not be shown. School buildings will be painted one color and residential homes another color. Parapets and overhangs will not be shown.
- 1.5 *Scale Forms:* Cars and people will be shown throughout the model, painted various colors.
- 1.7 Landscape: A separate price has been estimated for landscaping. Landscaping will be shown according to the landscape plan or aerial picture. Deciduous and evergreen trees will be shown.
- 1.8 Base: A 3.5" tall finished hardwood display base (mahogany, cherry or maple) will be provided with this model.
- 1.9 Cover: N/A
- 1.10 Crate: N/A.
