Lisa introduced Dom Puniello from GGD who will talk about the development of the energy model and the latest data that we are getting from that. He discussed the MA CHPS Energy Savings Analysis. The current energy savings predicted is 42.4% above the MA Building Code. We are 22.4% above the stretch code.
